5. DIRECTOR REPORTS 5.1. PRESIDENTS REPORT

Good evening everyone, thank you for coming to the AGM.

As always, I will try to keep this brief.

I would extend my thanks to all executive members, coaches, referees, and volunteers who helped our various programs.

REGISTRATION

Overall registration was down this Season with 330 players being registered in the association, this is slightly down from last year. This downward trend is of concern and reflects changes in local demographics, the cost of hockey and the net effect of losing players through the NRP process. A key policy to not allow releases for player who have signed a right of choice, implemented two years ago and strictly enforced this season, helps to mitigate these losses. We will continue to monitor the situation and act when possible. Our Treasurer will provide our financial position shortly, I am happy to say that she projects that we will likely break even at the end of the year. As in past years, positive revenue will be placed in the Association Reserve.

CHIP HOCKEY

Another successful season for our youngest group of players. The Hockey Canada Initiation Program is the cornerstone CHIPS, our Director and the Chip coaches did a great job leveraging the program to develop these young athletes. Hockey Canada has mandated additional changes in the program below Novice. In the upcoming season, our graduating Initiation Players will transition to Tyke and Cross Ice Hockey. This change is projected to extend to the novice program in the 2019/2020 season where Novice player will start out at half ice and transition to full ice as the season progresses. The OMHA has not provided final guidance regarding the format of competitive hockey for these players; my expectation is that the Tyke MD program we are all used to will be removed to be replaced with some form of Tiered hockey.

VOLUNTEERS

As I was preparing this report it struck me that we do not truly appreciate the number of volunteer hours that go into running a minor hockey program. There were 21 Active teams this season who played in 474 games. Each game averaged 40 minutes and had at least 3 volunteers on the bench that comes out to 948 volunteer hours on the benches for playing time. That does not include the time spent preparing for practices, running a practices, and dealing with all the in an out of running a team.

Behind this group we have the Association Executive who spends its time finding coaches, getting uniforms, setting up schedules, managing Ice and dealing with the CWEAH league, the Tri-county Hockey League and the OMHA. I would estimate that over 2000 volunteer



hours were put into running this Hockey Season. I would extend my thanks to all executive members, coaches, referees, and volunteers who helped our various programs.

ON ICE OFFICIALS

This year we moved to leveraging The Halton-Hill Referees Association for our on Ice officials. This gave us access to a larger pool of officials and gave our local officials the opportunity to work in other centres. I believe that this model served us well this year and that we should continue to use it.

In league play the Novice, Atom and Midget Teams played in the Smith Division which is composed of Major teams from A centres. The Atom AE team played in the Harrison Minor Atom Smith Division. All teams were in the TOP half of their respective divisions, well done.

5.2. TREASURERS REPORT

From a financial perspective, there are no surprises this year, so my talk tonight will be short.

Last year's audited financial statements show an excess of revenue over expenses of \$9,156 including interest. Before interest earned, our excess was \$8,481.

Our reserves are gradually being replaced, as we paid back \$10,000 in 2016 and \$5,000 in 2017.

This year, our excess of revenue over expenses before interest is forecast to be – expenses over revenue of \$850.

We did incur additional costs this season that were one-offs.

Thanks to Dawn all of our banners have been updated and our trophies have all the names from prior seasons; we purchased new trophies to be presented to the Local League Champion of each division (within EH).

We incurred some legal fees with respect to OMHA rules around right-of-choice and player release (\$2,000); We purchased boards for the Hillsburgh arena for the CHIP & Tyke program rules at a cost of \$4,100.

Our player population was lower, as Dennis mentioned, dropping from 350 members last season to 330 members this season. Most other costs were reduced, reflecting fewer players or other cost efficiencies such as no phone, no internet in the office, no printing for AGM as all is now done electronically. We joined the Halton Hills Referee Association this season, moved from Orangeville, which changed our costs slightly for refs & timekeepers but opened up opportunities for the teens who fill these roles and provided our association with a pool of refs, particularly for the more senior games.

For the board, these numbers are new. Unfortunately, I just received an invoice from the Town of Erin yesterday, providing us with a list of our costs dating back to December 1. Their preliminary list sent to me 2 weeks ago was \$15,000 lower than the current list provided. Some of the differences I was aware of, some were not.

In the end, we are a not-for-profit organization. We are very close to zero on the books this year and will continue to monitor our expenses to ensure the children in our community get the best hockey experience at the lowest rate possible.



If anyone knows of someone interested in learning about the financials of the organization and taking them over one year from now, please let me know. It's easier to show someone along the way than to hand over the books without any prior knowledge being passed along.
