# 5. DIRECTOR REPORTS

## 5.1. PRESIDENTS REPORT

Good evening everyone, thank you for coming to the AGM.

As always I will try to keep this brief.

I would extend my thanks to all executive members, coaches, referees, and volunteers who helped our various programs.

Hockey continues to be an expensive sport. Our largest expense is, and I suspect always will be, ice rentals. Ice rentals have gone up and we expect that they will rise again this year. Our ice scheduler works diligently to ensure we maximize our ice time.

The budgeting process introduced two years ago is still in use and I am happy to report that process used does align player costs to ice usage. Our Treasurer will provide our financial position shortly, I am happy to say that she projects that we will break even, and possibly show a positive balance at the end of the year. Should we have a positive balance some of those funds will be directed back to the Association Reserve. Any monies that do go into the reserve will be from donations and association fundraising.

## Registration

Overall registration was down this Season with 350 players being registered in the association, this is a drop of approximately 9%. In conversations with other local minor sports organizations there is a general consensus that registrations are down. We will continue to monitor the situation to determine if this is simply the result being a small centre and local demographics.

## **CHIP Hockey**

Another successful season for our youngest group of players. The Hockey Canada Initiation Program is the cornerstone CHIPS, our Director and the Chip coaches did a great job leveraging the program to develop these young athletes.

## 5.2. TREASURERS REPORT

Good evening.

I will be reporting on the audited financial results from the 15/16 hockey season, the forecast results for the current season 16/17 and then making a motion to approve our auditors for the coming year.

First, as reported last year, the 15/16 season ended with a profit of \$23,209. This was a big change from the loss of \$32,534 the year before. At the time, we did an in-depth analysis of our cost structure, revamped our budgeting system and implemented changes in our registration system for how funds are collected.

Last summer, we replaced \$10,000 of the reserves that were drawn on during the year of losses.

I am pleased to report that this year, I am projecting a profit of \$6,000. Technically, this is called an "excess of revenue over expenses" because we are a non-profit organization. This figure may fluctuate a bit because a couple of numbers have not been finalized. In fact, it may go up to \$8,000, but no lower than \$5,000.

There were no unexpected costs this season. While registration was lower than expected and some teams were smaller, we were able to adjust ice usage to reflect the reduced amount of funds coming in. Other costs remained steady.

EHMHA hosted only 2 tournaments this season, both over Christmas (not including the Atom AE tourney in September). We continued to invest in player development and coach development, with the reimbursement of 50% of the cost of courses for any coach in EHMHA being certified. One of the accounts to be updated is insurance. All our players who are refs will be reimbursed for the cost of insurance that is paid as part of their referee fees at the beginning of the season. Insurance is charged on their behalf as players and therefore they do not need to pay it twice. I will be issuing reimbursement cheques to all refs. It's not a huge amount, but it's saving the players/students money.

As is usual, the auditors issued a Qualified Opinion on the audit report. The reason for this is that many teams run fund-raisers and money is being handled within the organization that does not come through the association's bank account. Other than that issue, the auditors raised no concerns on the condition of the books or the financial statements.

At this time, I'd like to make a motion to nominate MacGillivray Chartered Accountants as our auditors of record for the 2017/2018 hockey season.
