

## **Town of Erin COVID-19 Recreation Facility Procedures**

**ALL** eligible participants and spectators are required to have two valid COVID-19 Vaccinations. Upon entry, everyone will be required to show proof of vaccination via digital or paper copy as well as complete the Town of Erin pre-screen document.

### **When you need to show proof of vaccine**

- Patrons 18 years of age and older accessing sport and fitness facilities for any purpose, including parents or guardians of youth participating in an organized sport.
- Youth 12-17 attending public skating
- Youth 12-17 spectating, including sporting events
- Patrons 12 and older attending banquet halls and community centre meeting rooms used for social gatherings or programs
- Patrons 12 and older attending entertainment/cultural venues such as theatres and concert venues

### **You do not have to show proof of vaccination if you:**

- are under age 12
- are under age 18 and entering the indoor premises of a sports or recreational facility solely for the purpose of actively participating in an organized sport
- have a valid document from a physician or nurse practitioner saying you have a medical exemption from full vaccination

When you arrive at the facility, the dressing rooms in the building at the Erin Arena and Hillsburgh Arena, all participants are reminded that they are to keep 6 ft. / 2 m distancing from each other.

The staging area is available 20 minutes before the booking and the Arena lobby Doors where you will enter will be closed until Town staff are ready to screen participants.

Young participants without a parent will need to provide proof of Pre-Screening or their name and phone number and answer the COVID-19 questioner/wavier.

When entering the Arena lobby players will follow the directional indicators towards the dressing rooms designated for on ice participants.

Spectators will follow the directional indicators towards the Arena stands where social distancing markers are indicated.

### **Lobby viewing is currently unavailable and spectators will be asked to leave**

Once the rental is over all participants and spectators are required to leave the Arena and lobby within **20-minutes and proceed directly to the parking lot.**

**Individuals, groups and organizations that don't adhere to the facility rules outlined in this document or posted in the facility can be penalized with a 2-week suspension from using the Town of Erin Facilities.**

As organizations, permit holders and on ice coaches you are responsible for your group the entire time they are on the premises and their adherence to the rules. **TOWN OF ERIN PRE-SCREENING TOOL (Must be complete to enter)**
